This policy is intended to comply with applicable U.S. federal law, North Carolina law, and mobile carrier requirements for A2P 10DLC messaging.

1. Information We Collect

We may collect the following types of information:

- **Personal Information:** Name, email address, phone number, mailing address, or other contact details you voluntarily provide.
 - **SMS Information:** Mobile phone number, opt-in consent status, message history, and interaction data.
 - **Technical Information:** IP address, browser type, device information, and website usage data collected via cookies or analytics tools.

2. How We Use Your Information

We use your information to:

- Provide and improve our services
- Communicate with you regarding your account, services, or requests
- Send **SMS messages only to users who have explicitly opted in**
- Respond to inquiries and provide customer support

- Comply with legal, regulatory, and carrier requirements

3. SMS Messaging & Consent (10DLC Compliance)

By providing your mobile number and opting in, you consent to receive text messages from NETLEVER related to our services.

Key SMS disclosures:

- Message frequency may vary
- Message and data rates may apply
- You may opt out at any time by replying **STOP**
- You may request help by replying **HELP**

Text messaging opt-in data and consent are not shared with any third parties, except with messaging service providers and aggregators strictly necessary to deliver our text messages (for example, SMS platforms and mobile carriers).

4. Data Sharing and Disclosure

NETLEVER does **not sell, rent, or share** your personal information for marketing purposes.

We may share information only:

- With trusted service providers who assist in operating our website or SMS services
 - To comply with legal obligations or lawful requests
 - To protect the rights, safety, and security of our users and systems

5. Data Security

We implement reasonable administrative, technical, and physical safeguards to protect your information. However, no system can be guaranteed to be 100% secure.

6. Your Rights

Depending on applicable law, you may have the right to:

- Access the personal information we hold about you
 - Request corrections or deletion of your data
 - Withdraw consent for SMS communications at any time
